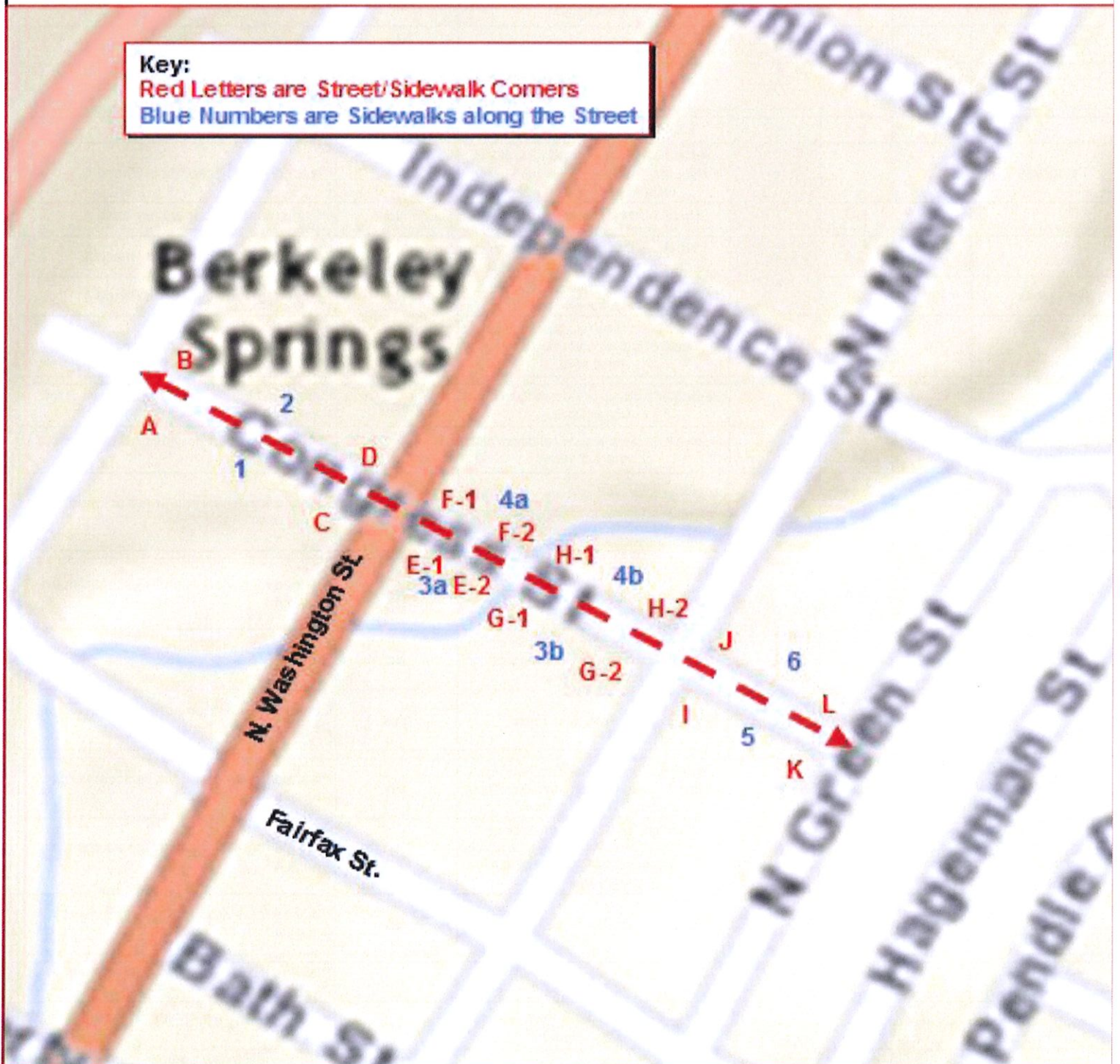

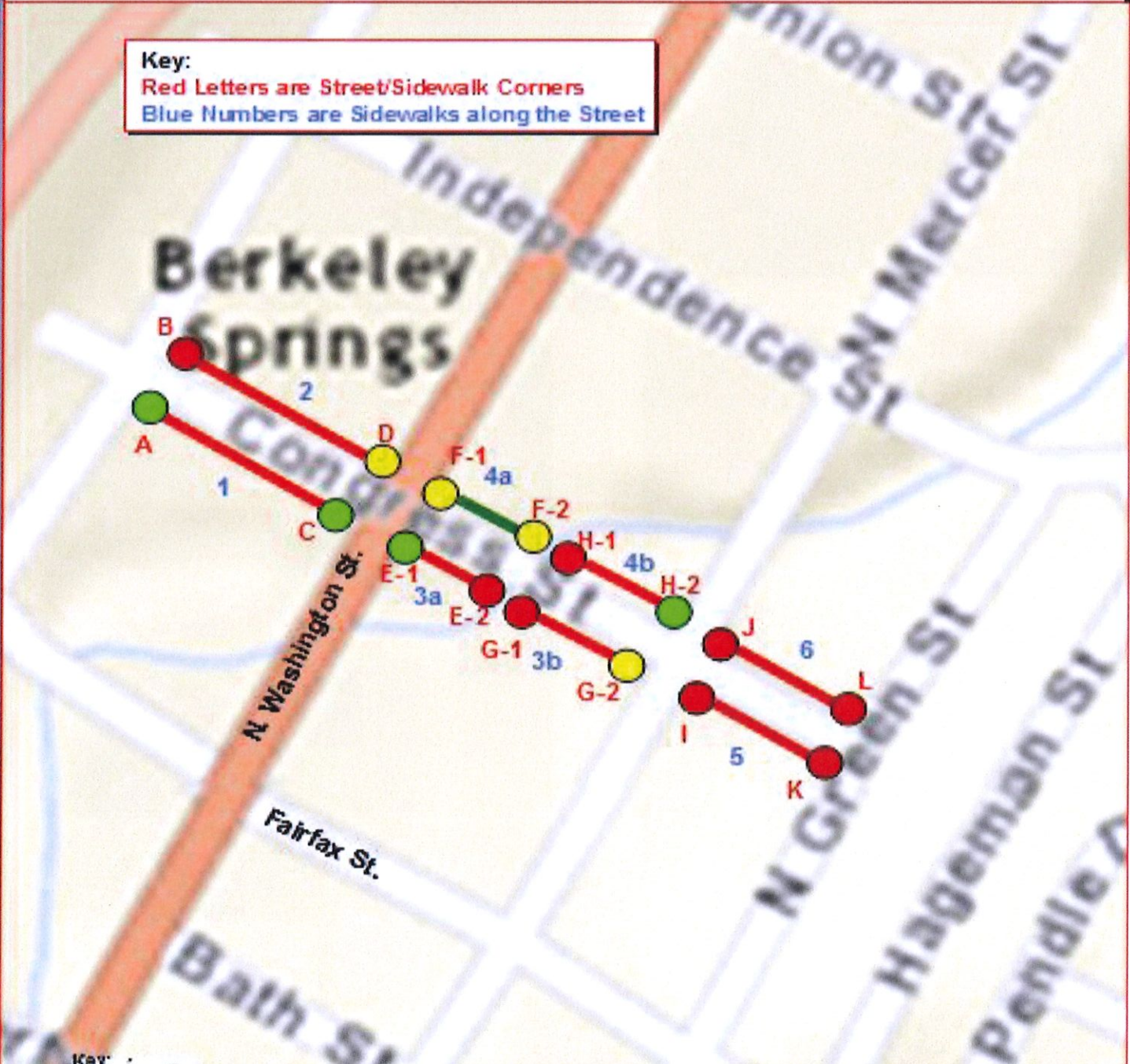

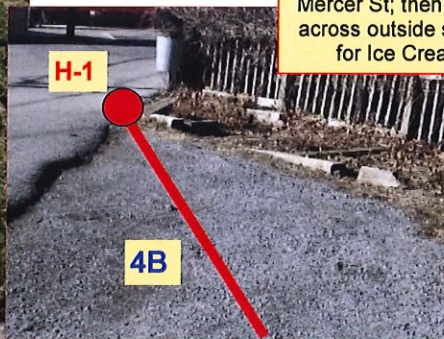
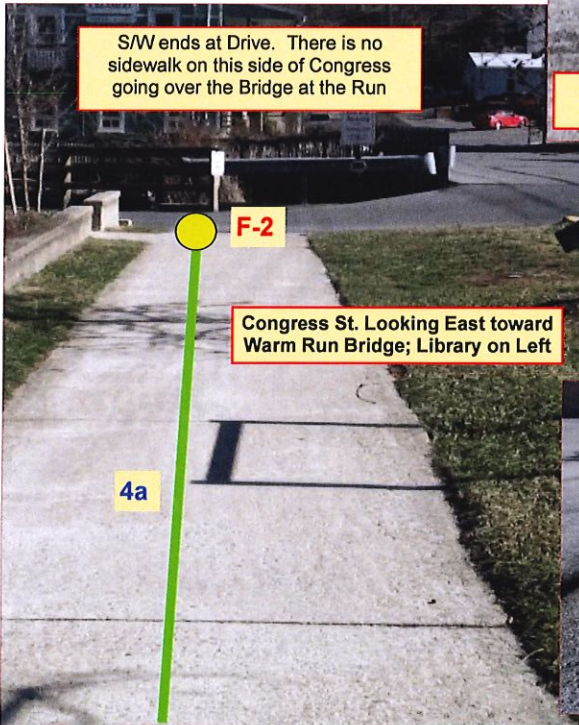
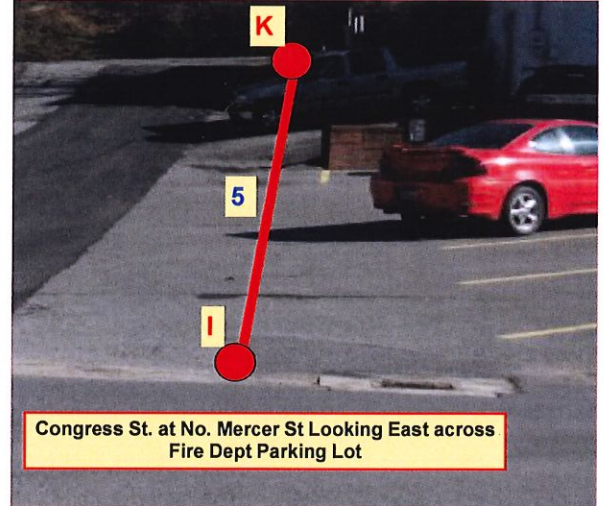
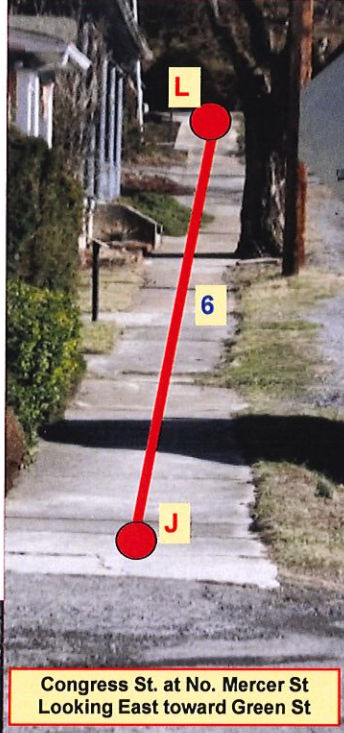
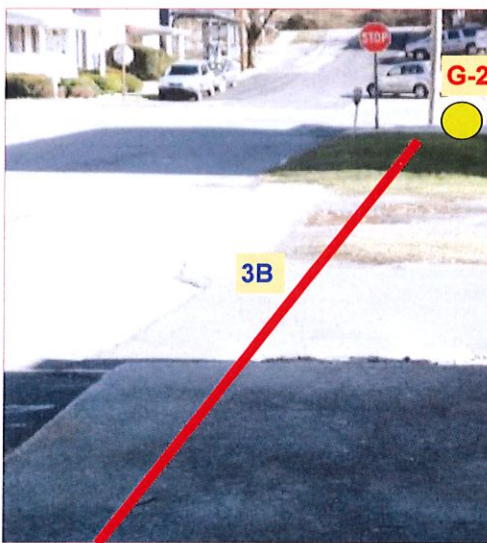
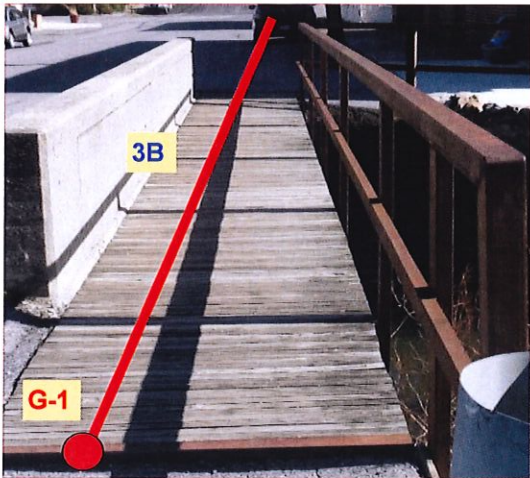
Key:
