- 1. CALL TO ORDER: @ 5:30pm by Mayor

- 4. PERSONS BEFORE COUNCIL: The Mayor requested that the Morgan County Parks & Rec report and the Historic Landmark Commission report be moved up on the agenda for the convenience of attendees. This was approved by Common Consent.
