AMENDMENT TO ORDINANCE #2-101 TIME AND PLACE OF COUNCIL MEETINGS

CHAPTER 1-Governing Body

Section 2-101 Time and place of Regular Meetings

The Council shall hold regularly scheduled meetings at least twice monthly on days and times to be determined by each newly elected Council for the duration of the Councils' tenure, in the Council's Chamber, at the Town Hall. The Mayor, the Recorder, or any three members of the Council may call special meetings as deemed necessary.

The Town shall make available, in advance, the hour and place of all regularly scheduled meetings of the Council to the public and news media:

A notice shall be posted by the Recorder/Public Utility Clerk at the front door of the Town of Bath Council's Chamber stating the hour and place fixed and entered on record by Council for the holding of regularly scheduled meetings. If a particular regularly scheduled meeting is cancelled, a notice of such cancellation shall be posted at the front door of the Council's Chamber.

The Recorder/Public Utility Clerk, at the front door of the Council's Chamber, shall post a notice at least two days prior to any special meeting. If the special meeting is cancelled, a notice of such cancellation shall be posted at the front door of the Council's Chamber.

AN ORDINANCE AMMENDING CHAPER 4, SECTION 28 "REMOVAL AND DISPOSAL OF ANIMAL WASTE" OF THE TOWN OF BATH MUNICIPAL COURT

BE IT THERFORE ENACTED AND ORDAINED BY THE COUNCIL OF THE TOWN OF BATH TO AMMEND CHAPTER 4, SECTION 28 OF THE TOWN OF BATH MUNICIPAL CODE, TO BE ENACTED AS FOLLOWS:

SEC 4-28, REMOVAL AND DISPOSAL OF ANIMAL WASTE

(A) NO PERSON OWNING AND HAVING CUSTODY OF ANY ANIMAL SHALL PERMIT SUCH ANIMAL TO DEFECATE (SOIL) UPON ANY SCHOOL GROUNDS, PUBLIC STREET, ALLEY, SIDEWALK, TREE BANK, PARK, OR ANY OTHER PUBLIC GROUNDS OR ANY PRIVATE PROPERTY WITHIN THE MUNICIPALITY, OTHER THAN THE PREMISES OF THE OWNER OR PERSON HAVING CUSTODY OF SAID ANIMAL UNLESS SAID DEFECATION (SOILING) IS REMOVED IMMEDIATELY AND DISPOSED OF IN AN APPROPRIATE MANNER AND CONTAINER.

ANY PERSON, UPON CONVICTION FOR FAILING TO COMPLY WITH SEC 4-28, SHALL PAY A FINE AS SET FORTH IN SEC 4-29 GENERAL PENALTY, CONTINING VIOLATIONS.
