## TOWN OF BATH SPECIAL ORDINANCE 2022-08-0207-01

Amending in part Chapter 42 Historic Preservation Article II <u>Historic Landmarks Commission</u> Section 42-19. Established.

Whereas, the Town of Bath in its plenary power and authority as a Class IV Municipality in the State of -West Virginia in the year 2000 ordered the establishment of the Town of Bath Historic Landmarks Commission through Ordinance #000-10 in accordance with West Virginia Code 8-26A-4; and

Whereas, the Town of Bath Council amended the order establishing the Historic Landmarks Commission in 2016 <u>under Ordinance #2016-01</u> changing the number of members to be appointed to the Commission and their residency requirements; and,

Whereas, it has been discovered that the amendments to the original Ordinance #000-10 does not comply with West Virginia Code 8-26A-4 along with other provisions of the current Chapter 42, Article II, of the Town of Bath Ordinances and current concerns of the Town of Bath Council; and,

Whereas, the Town of Bath Council desires to comply with West Virginia Code 8-26A-4 and satisfy membership residency concerns of the Historic Landmark Commission as expressed to the Council by citizens of Bath; and,

Accordingly, it is therefore ordered that the Town of Bath Council hereby amends in part Chapter 42 Historic Preservation Article II Section 42-19. The five members shall be appointed from Town of Bath residents. b.—The five members shall be appointed at a minimum of three-fifths from Town of Bath residents with any remaining members being property owners of Bath whose principal residence is in Morgan County." -b.
