- 3. Finance Committee Minutes of February 7, 2023 were approved by Common Consent.
- 4. Grant Review Reports:
- a. Streetscape, NBRT: See attached updates. WV DOH Project Manager Kyle Oliver was in Bath on February 16, 2023 to meet with the Streetscape, R/T, Berkeley Springs State Park and Depot committees to inspect the projects. Chairwoman Webster, Streetscape and R/T Co-Chair Rebecca MacLeod and Berkeley Springs State Park Foundation President Pete Gordon guided Project Manager Oliver through the projects' progress and future plans.
- b. Depot: Webster reported that progress is ongoing with the interior rehabilitation of the Depot. It has come to her attention that the sanding and finishing of the hardwood flooring portions of the Depot were not part of the original interior rehab design. A preliminary cost estimate of this work is \$7,500.00 and will have to be borne by Town. She also presented a letter she has written to Senator Manchin (attached) requesting his intervention in the described TE matching fund grant issue that has caused an unexpected financial burden.
- 5. Clerk Corrick's report, budget comparison, account balances and payroll information were reviewed and accepted with clarifications.
- 6. Town financial concerns of Council:
- a. Councilman Weber explained a concern of the Public Works Committee. At present overtime snow removal pay is a flat \$20.00 per hour for all Labor Crew employees working the cleanup. It was requested that in place of that pay scale that those employees be paid \$10.00 per hour more in addition to their regular hourly wage. After discussion the request was granted.
- b. Clerk Corrick presented her request for write-offs for bills that have become uncollectable due to various reasons. The bills were reviewed and the request was granted.
- 7. The BSWW and Town of Bath bills were reviewed and will be presented to Council for approval.
- 8. The next regular meeting will be March 7, 2023 at 4:00pm.
