September 5, 2023

1. CALL TO ORDER: @ 5:30pm by Mayor.

2. ROLL CALL: Scott Merki (X) Susan Webster (X) Elizabeth Skinner (X) Greg Schene (X) Rebecca MacLeod (X) Mary Lynn Hickey (X) Tom Hall (X) Quorum present.

3. REVIEW OF MINUTES: Minutes of the Regular Meeting of August 22, 2023 were

approved by Common Consent.

4. PERSONS BEFORE COUNCIL: Town residents Donna Coates and Melissa Schod appeared before Council to present their plan (attached) to reestablish the Town of Bath Community Garden organization. Discussion was had and concerns of Council were addressed.

MOTION: To accept the plan to reestablish the Town of Bath Community Garden organization as presented- MacLeod/Hickey - Carried

Ye Town of Bath DAR Regent Gail Potter and members requested that the Mayor and Council approve the attached Constitution Week Proclamation.

MOTION: To approve the Ye Town of Bath Constitution Week Proclamation-Webster/Skinner- Carried

5. <u>COMMUNICATION FROM MAYOR</u>: The Mayor announced the Morgan County Homeless Coalition "Walk a While in their Shoes" event to be held September 9, 2023 from 10am until noon. Councilwoman Hickey further described the event which includes a pig roast at the Hope House and encouraged participation. The Morgan County Partnership is again sponsoring the Zombie Walk to be held on October 21, 2023. They requested permission to have the first block of Fairfax Street east blocked from traffic from 1-4pm that day and provided the route they will use (attached).

The Morgan County Jeepers requested that the there be no parking on the first block of South Washington Street on the park side during their events in the Berkeley Springs State Park on September 23, October 28 and December 9.

Recorder Webster proposed that it be considered that in the future all Bath facilities use, including street closures and parking restriction requests require the submission of a Facilities Use Application due to Town expenses incurred during these events. A minimum charge of \$100.00 was discussed. Further development of the proposal will proceed.

5. STREETSCAPE: Committee Co-Chair Pete Brown has submitted reports on Streetscape, the Berkeley Springs State Park and the Greenway mausoleum projects to the Town (attached).

- 6. TRAIN DEPOT: Chairman Webster submitted a Facilities Use Application for the Depot lot for vehicle parking during the Apple Butter Festival. All proceeds will be donated to the Depot project for future improvements.

- 7. LANDMARK COMMISSION (HLC): Next meeting is September 21 at 2pm.

8. CLERK/RECORDER REPORT: No report at this time.

- 9. FINANCE: Chairwoman Webster delivered the following bills for approval:

 - (f) Streetscape \$993.00- Motion to approve: Webster MacLeod- Carried Councilman Schene conveyed the Committee's intent to diligently work to administer Bath finances using best practices.
- 10. TREE BOARD: Councilwoman MacLeod announced that the Warm Springs Watershed Association plans a mulching and maintenance day on September 12 from 9am until 1pm. The Berkeley Springs High School Future Farmers of America organization will assist in this necessary work.
- 11. GRANT: The next meeting is September 11 at 4:30pm. Chairwoman Hickey reported that the Committee is drilling down on the priority of needs of the community. She hopes to focus on public safety necessities such as the BSVFD fire truck, cameras, safety vests and officer pay.
 - 12. PUBLIC SAFETY: The next meeting is September 13. Chief Carper has arranged meetings with additional company prospects to bid on supplying the Town with video surveillance.
- 13. CEMETERY: The next meeting is August 23. Councilwoman Skinner reported that mowing is finished in Greenway Cemetery for the year. She is waiting for quotes for the mausoleum repair work. Contractors have until September 15 to respond. A family is researching masonry work needed on a wall near the front of Greenway at their family's plot. Skinner will keep Council updated.
- 14. PUBLIC WORKS: Chairwoman MacLeod advised that repairs are being made on

equipment and that two trucks and the tar buggy have been sold. Paving will begin soon on Green Street from Rt. 9 to Fairfax Street.

15. ORDINANCE: The next meeting is September 20. Chairman Schene is visiting

Shepherdstown to research the benefits of Home Rule.

16. BSWW: Chairman Hall reported that the committee is preparing for the next meeting on August 20. The BSWW is planning for the retirement of Superintendent Jainniney.

17. PUBLIC COMMENT: Lisa Swanson of Duane Street inquired about maintenance issues on that street. Public Works Chairwoman MacLeod will look into the issues. Alex Teixeira expressed concern about the speed of vehicles traveling on North Washington Street traveling south on this street near his home and business, The Trail Depot. He is also worried about people crossing N. Washington Street to Williams and the Berkeley Depot with no crosswalk at the location. The Mayor and Chief explained their current work toward obtaining an electronic speed indicator and a crosswalk for the location.
